### **Minutes:**

Minutes of the tenth meeting are as follows:

- 1. Minutes of the eighth meeting held on 06<sup>th</sup> Dec., 2014 were read by Dr. Mirza S. B, the Coordinator IQAC and approved by the members. (as 09<sup>th</sup> meeting was exclusively for communicating the college accreditation grade)
- 2. All the committee members agreed on submission of annual college committee reports to IQAC office upto 01/05/2015.
- 3. It was unanimously agreed to submit PBAS and Self Appraisal Proforma to office upto 01/05/2015 which will be helpful in maintaining personal records and issuing *Letters of Appreciation* and *Confidential Reports*.
- 4. IQAC members actively participated in the discussion of theme of the magazine. They discussed on the current burning issues and suggested that *Dnyandhara*, the college magazine should focus on Flood and Draught situation in India and students role in preserving natural resources. The central theme should be related to farmers' suicides, water literacy and management. This year Dr. Mirza S. B. is the editor of this issue, he assured that the magazine will be ready for inauguration on Birth Anniversary of founder president Dr. Shankarraoji Chavan on 14/07/2015.
- 5. All the members of IQAC discussed in detail the draft AQAR presented by the IQAC coordinator and suggested some changes. All the members unanimously consented for submission of AQAR and Utilization Certificate to UGC.
- 6. The IQAC insisted on nomination / election of new members on Local Management Committee (LMC) which will dissolve this academic year. The same topic is forwarded

- to Dr. Paikrao S. S, the Staff Secretary for discussion in staff meeting. IQAC hoped that this time also the staffs will forward names unanimously as usual.
- 7. As per the suggestions of the NAAC Peer Team, there is need to give representation from students, industry and social field. It was accepted to include their representation from next academic year.
- **8.** All the IQAC members unanimously congratulated the principal for giving *Letters of Appreciation* and *Confidential Reports*. It is an effective method of evaluating teachers' quality and their contribution. They appreciated and solicited to continue this year as well.
- 9. The College has submitted a proposal seeking permission to start B.Com. Course from next academic year 2015-16. The Affiliating University has conveyed wide letter no. Acad./Affil.-3/2015-2016-548 dated 25/07/2015 that state government has directed not to permit starting of new courses in any college. So, B. Com. Course cannot be started this year.
- **10.** The committee for preparing Vision-Draft 2020 of college is working over it and it is expected that it will submit the Vision-Draft within six months.
- 11. Dr. Mirza S.B. informed that Swami Ramanand Teerth Marathwada University, Nanded gives awards annually to Best College in its jurisdiction under Urban and Rural category each, in form of Certificate and Rs. 25000/-, on the occasion of University Establishment Day i.e.17 September every year. As the college is fully upgraded and accredited by NAAC, it is eligible for submitting proposal of Best College Award. All the IQAC members applauded to this suggestion and consented to submit the proposal in the month of August.
- 12. No matter was discussed apart from the given agenda.
